*HOHUDO California Education Code Section 68130.5, exempts any student, other than one with a United States Citizenship and Immigration Services (USCIS) non-immigrant visa status (*see exception below for students who have been granted Temporary Protection Status or U visa), who meets all of the following requirements, shall be exempt from paying nonresident tuition at the California Community Colleges, the University of California, and the California State University (all public colleges and universities in California).

Eligibility Requirements

The student must have:

1. Satisfied either of the following:
 - a. attended a high school (public or private) in California for three (3) or more years, **or**
 - b. attained credits earned in California from a California high school equivalent to three (3) or more years of full-time high school course work and attended a combination of elementary, middle and/or high schools in California for a total of three (3) or more years, or a combination of those schools. **or**
 - c. attained credits earned at a California adult school, **or**
 - d. attained credits at a California Community College, **or**
 - e. a combination of the schools listed above.
2. Graduated or will graduate from a California high school, **or**
 - a. attained a General Education Development (GED), High School Equivalency Test (HiSET), Test Assessing Secondary Completion (TASC), **or**
 - b. attained an associate degree from a California Community College, **or**
 - c. fulfilled the minimum transfer requirements to transfer from a California Community College to a University of California or California State University, **and**
3. Will register or enroll in an accredited and qualifying California college or university, **and**
4. If applicable, complete the affidavit stating that you will legalize your immigration status as soon as you are eligible, **and**
5. Do not hold a valid non-immigrant visa (A, B, C, D, E, F, J, H, L, etc.) *
